

Implementing Vernal Pool Habitat Management Guidelines (VPHMG's)

Please join us for an educational experience to learn about, view, and discuss the application of both wildlife habitat management guidelines for vernal pools and expanding gap silvicultural systems. A collaborative effort involving state and federal agencies, forest managers, and the conservation community produced a set of Vernal Pools Habitat Management Guidelines (VPHMGs). The guidelines provide managers with details about both vernal pool ecology and recommendations for appropriate silviculture and harvesting practices in the vicinity of vernal pools. The University Forest has installed a demonstration site on the Demeritt Forest showcasing one example of implementing the system in accordance with recommended forestry practices around vernal pools and two variations of the expanding gap silvicultural system. Harvest operations occurred this winter. Tour leaders include foresters, wildlife ecologists, and other natural resource professionals.
